RATES

Each job is unique and many variables apply. Therefore, Over + Above Media prefers to quote on an individual project basis, after having a full briefing on your requirements.

However, we appreciate that sometimes you may want a quick ballpark cost. Therefore as a quick guide our “from” prices are as follows, based on a *half day rate*:

- AERIAL PHOTOGRAPHY FROM £295 + VAT
- AERIAL FILMING FROM £495 + VAT
- AERIAL FILMING & STILL PHOTOGRAPHY (EDITED) FROM £895 + VAT
- EDITING PACKAGES AND FILM CREATION WITH GRAPHIC IDENTS & LICENSED MUSIC FROM £595 + VAT

AVAILABILITY, BOOKING & DEPOSIT

To check our availability please contact us as soon as possible to secure your preferred filming date.

A completed Order Form is required in respect of all assignments. All written quotations will be valid for 30 days, and will be supplied on receipt of a clear written quotation request from the Client. In addition to the aerial photography, the amount quoted will be inclusive of all preparatory work, travel (up to one hundred miles round trip from Over + Above Media’s offices in Northumberland), and delivery of proof and/or finished material.

Over + Above Media will use best endeavours to provide an accurate representation of the subject(s), there can be no guarantee implied or otherwise to match the colour perceived by the human eye.

Elevated platform photography may require Police, Local Authority and/or Parking Enforcement permission, if it is necessary to operate in a public place. All work is

subject to obtaining suitable permission and legal access from which to safely operate the aerial equipment. Where it is necessary to enter upon private land, it is expected that the Client will obtain the necessary permissions from the land owners and/or occupiers.

VAT will be applied at the prevailing rate on the total quoted price. A series of related assignments will be treated as individual contracts. If a site survey is needed prior to the quotation this will be agreed in advance and may be invoiced separately.

Due unpredictability of the weather in the UK and the nature of film shoots we do our best to be flexible when working with clients. We are happy to pencil in potential jobs and dates for Clients. However, actual bookings will always take priority.

We require 30% deposit at time of the booking to be paid in advance.

Limitation of Liability - Weather, Force Majeure, Act of God and other Constraints

As with any location photography, a successful assignment is dependent upon suitable weather conditions. A decision to photograph on a particular day is normally delayed to the last practical moment to maximise the chance of suitable weather.

Should the weather on the day not be as forecast or anticipated and the assignment needs to be postponed, there will be no additional charge to the Client for a return visit to complete the work. Over + Above Media will always endeavour to complete its assignments by any proposed completion dates.

However, due to weather and other constraints, Over + Above Media cannot guarantee completion by any specific dates. It, therefore, cannot be held responsible for any missed publishing or other deadlines or any other consequences involving the timing of the commission. The completion of work is subject to alteration and cancellation due to any causes beyond our control. Certain specific shots, included in the brief and quoted to be undertaken, may not be possible on the day for various operational reasons. In this situation, the best possible alternative shot(s) will be supplied and these will be deemed to fulfil the contract. In any event, the liability of Over + Above Media will be limited to the total value of the contract with no liability accepted for indirect and/or consequential loss.

CANCELLATIONS

If due to weather (i.e rain, strong winds etc) and we are not able to shoot we shall not charge the client if we can make alternative arrangements for the shoot to happen at another time. The 30% deposit is simply transferred to another day when we can shoot.

If the shoot cannot be re-scheduled we will discuss cancellation policy and potential fees with the Client and come to a fair and reasonable compromise.

If a job is cancelled due to other issues and simply not re-scheduled due to the client no longer requiring our services the 30% deposit will not be refunded unless by pre-agreement.

An administrative charge may apply to recover expenses incurred if any preparatory work has been undertaken on behalf of the Client.

PAYMENT TERMS

All invoices are payable within 14 days unless by prior agreement. Over + Above Media reserve the right to withdraw any services or work for accounts that are overdue.

TRAVEL EXPENSES

Travel expenses will be charged at 50p per mile. Additionally should it be necessary to arrange accommodation this will be at the clients cost.

COPYRIGHT AND USAGE RIGHTS

Full personal reproduction rights of the commissioned material supplied passes to the Client upon full settlement of the final invoice. This allows reproduction for all uses stated on the quotation and Order Form. 'Marketing' use excludes use for merchandising, for which an additional fee may need to be negotiated.

Legal use of the images by any third party, not directly on the Client's behalf, will only be granted following written permission from Over + Above Media. This will incur a negotiated Reproduction Fee.

Moral rights will always be required in that the name of the author of photographs (i.e. Over + Above Media), commissioned or otherwise, is suitably credited whenever the image is published or displayed. Over + Above Media retains copyright of all photographic images and video footage supplied and reserves the right to use any of the images for photographic library and other uses.

We reserve the right to use ANY of our footage for internal promotion, whether this be inclusion on our show reel for PR purposes to promote Over + Above Media. Also we reserve the right to potentially supply the footage to stock libraries after the initial use of the footage has been published by the client.

If you have any questions or issues with the above we would ask you to kindly speak to us in advance of filming.

PUBLIC LIABILITY INSURANCE

Above and Beyond Media has all necessary insurances including Public Liability Insurance with an indemnity of up to five million pounds sterling.
